

#### **Annual General Assembly of the Vienna NGO Committee on Drugs**

Due to COVID-19 the VNGOC Board decided to hold all meetings during the 64th CND online, including the Annual General Assembly. The VNGOC Board and the Nominations Committee further decided to deliver the General Assembly in two parts:

- 1. Part 1 of the AGM was held on <u>Thursday 8th April 2021</u> (15:00 17:00 Vienna time) using Zoom
- 2. Part 2 of the AGM was held on <u>Thursday 15<sup>th</sup> April 2021 (</u>16:30-17:30 Vienna time) using Zoom

#### **DRAFT MINUTES**

#### **AGM PART 1**

#### 1. Adoption of the Draft Agenda

The Committee adopted the draft agenda.

#### 2. Attendance and apologies for absence

113 people attended Part 1 of the AGM and 70 people attended Part 2 of the AGM. 150 member organisations in good standing registered to vote in the VNGOC elections. (see Annex 1)

No apologies were received by the Secretary prior to the meeting.

#### 3. Approval of the minutes of the last meeting

The <u>draft minutes</u> of the meeting held on 04 March 2020 have been circulated. The Committee **approved** the draft as a correct record of the meeting.

#### 4. Membership

The Committee was informed about the latest applications for membership and the new members were officially introduced.

64 new organisations from 39 different countries were admitted since March 2020, bringing the total membership to 318 organisations. The list of new member organisations can be found here.

Several members raised concerns regarding the large number of new organisations with a similar name. The Board reiterated that only independent organisations can join the VNGOC and that the new members fulfill this and all other membership



criteria as far as they could ascertain. As much of the process is based on good faith, the membership was encouraged to look at the list of VNGOC members and give feedback to the Board if they have specific concerns regarding the eligibility of an organisation.

#### 5. Annual Report

The Board presented the VNGOC <u>annual report</u> and reflected on activities for 2020. In particular, the Board presented civil society speaking opportunities in 2020 and the range of speakers selected by the VNGOC. The annual report was **approved**.

#### 6. Financial Report 2020 and Budget 2021

The Board informed the Committee about the annual accounts for 2020 and the latest financial status – contained within the annual report. The Auditors, Mousa Daoud (Jordan Green Crescent) and John Redman (CADFY), confirmed their **approval** of the financial documentation.

The Board presented the budget for 2021, and the Committee **approved**.

7. Proposal from the VNGOC membership to change the election procedure Stig Erik Sørheim, representing EURAD, presented a <u>proposal</u> regarding new procedures for VNGOC Board elections which had been submitted on behalf of several member organisations. The proposal was put forward by EURAD, IDPC, Movendi International, MUCD, Dianova, Forut and TB/HIV Care Association in accordance with the VNGOC statutes.

After a discussion among the members present (see below), the proposal – to form a working group and further explore possible changes to the election process, and also to delay the formation of the 2022 nominations committee until October 2021 – was **approved** by the Committee by acclamation, with no formally registered objections and one formally registered abstention.

The following ideas and suggestions were brought up by members of the Committee during the discussion:

Mousa Daud (TJADS) and Memory Usaman (Rwanda Youth Impact) proposed to delay the discussion and the formation of a working group until next year as they felt that more time was needed to explore and discuss the proposal.

<u>Tajudeen Abiola (Green Crescent Health Development Initiative Nigeria)</u> raised the issue of gender balance mentioned in the proposal and asked whether it is truly relevant for the issue as organisations and not individuals are represented in the VNGOC. He also pointed out that "geographical representation" and "balanced



representation" are vague terms and need to be more clearly defined and put in a context. In addition, he voiced concern that the proposed time period might be too short to come up with a good proposal.

<u>John Redman (CADFY)</u> also agreed regarding the timing of the proposal, especially considering the COVID-19 pandemic and the restrictions on in person meetings that might make robust debate more difficult.

Through comments in the chat, several members pointed out the importance of gender balance in all aspects of our work. It was also noted that the proposal was simply to begin a discussion via a working group, and not to make any binding decisions at this time.

Stig Erik Sørheim (EURAD) then addressed the issues raised, saying that especially regarding gender balance and other terms mentioned the proposal had been kept deliberately vague as further exploration and discussion should be done by the working group. While we have had gender balance on the Board so far, it is important to make sure that the membership does not select an all-male or all-female Board in the future.

<u>Amy Ronshausen (Drug Free America Foundation)</u> suggested a series of online discussions in the coming months to allow as many members as possible to discuss this idea and to give their input.

<u>Beyza Kartal (Verein Neubeginn)</u> pointed out that gender balance and regional representation are important aspects to always keep in mind, but cautioned that "balanced representation" was a very vague term and that in-depth discussions would be needed with plenty of time to explore.

<u>Shane Varcoe</u> (<u>Dalgarno Institute</u>) drew attention to the composition of the working group and asked how that would be formed.

Stig Erik Sørheim (EURAD) responded that the working group would be formed by volunteers from the VNGOC membership and re-emphasized that the proposal is only to have a conversation at this time, and changes would only be proposed after in-depth discussion both in the working group and among the broader membership.

<u>Shane Varcoe (Dalgarno Institue)</u> proposed a rolling consultation in different regions and a recruitment mechanism for the working group to ensure gender and regional balance already in the working group itself.



<u>David Borden (DRCnet)</u> pointed out that online discussions had the potential to increase participation and suggested to support members without stable internet access.

<u>Nazlee Maghsoudi (CDPCE)</u> drew parallels to other work of the VNGOC and the Civil Society Task Force (CSTF), where balancing different aspects of drug policy, and ensuring gender balance and geographical diversity are always central. Beginning a conversation on how to better incorporate these variables in the Board seems to align very well with our working principles. Any proposals by the working group can then be discussed and voted on at the proposed Extraordinary General Assembly later in 2021, and even if a future proposal would be approved by the membership there wouldn't be any actual change in the voting process.

<u>Jamie Bridge (VNGOC Chair)</u> then attempted to summarize the suggestions put forward by the members, especially that:

- an open call would be issued by the Board for working group participants
- a series of meetings geared toward different time zones to facilitate discussions and enable broad engagement
- provide internet access to people if they are unable to join because of challenges with the infrastructure

#### 8. UNODC update

The Committee received an update on developments within UNODC from the Civil Society Unit. The Civil Society Unit especially highlighted the successful webinars conducted together with the VNGOC, and also drew attention to Crime Congress that took place in March 2021 (the first virtual meeting to take place outside of a UN Headquarter). Lessons learned from this important event also impact the CND,



and include a greater number of online slots for NGOs at the 64<sup>th</sup> CND. 20% of all available slots are dedicated to civil society organisations.

#### 9. VNGOC Board elections

The nominations committee (Orsi Feher, Rogers Kasirye, Clement Bofa-Oppong, Ezze Eluchie) presented the procedures for the online Board elections, which were also circulated before the meeting, and each candidate had the opportunity to briefly address the membership. The elections were held online via electionrunner.com in the following order (all times CET):

- a) Chairperson: Monday, 12<sup>th</sup> April 11am to Tuesday, 13<sup>th</sup> April 10am
- b) Deputy Treasurer: Tuesday, 13<sup>th</sup> April 11am to Wednesday, 14<sup>th</sup> April 10am
- c) Deputy Secretary: Wednesday, 14<sup>th</sup> April 11am to Thursday 15<sup>th</sup> April 10am

The meeting was then firmally paused by Matej Kosir (VNGOC Deputy Chair) for the duration of the elections, to be resumed on Thursday 15<sup>th</sup> April, 4.30 pm CEST.



#### **AGM PART 2**

#### 10. VNGOC Board elections (continuation of item 9)

Out of 174 members in good standing, 150 registered to vote in the Board elections. The final results were confirmed by the nominations committee as follows:

On behalf of the VNGOC Board, Jamie Bridge (Chair) thanked the nominations committee and all the membership for their cooperation and understanding during the unprecedented online elections this year. Jamie also formally registered thanks to Sarah Pirker, VNGOC Project Officer, for overseeing the whole process, and especially thanked Zoran Jelic (Stijena Resoc), who served as a Deputy Treasurer from 2018 to 2021, for his outstanding work as a Board member.

#### 11. Appointment of an auditor

The membership was asked to nominate and confirm an auditor. Beatrix Vas (Students for Sensible Drug Policy) volunteered and was **appointed for two years**, replacing Mousa Daoud (Jordan Green Crescent).

#### 12. Any other business

<u>Michael Kraevitz (Veterans for Safe Access)</u> raised the issue of speaker selection and asked the Board to re-examine the selection process as he felt that especially when it came to the CND discussions on cannabis, his stakeholder group had been underrepresented. The Board invited all members to review the existing selection criteria and process (<u>available here</u>) and make any formal suggestions for changes that could be made.

<u>Kenzi Riboulet (FAAAT)</u> asked the Board to explore the possibility to formalize the informal dialogues with the CND, UNODC, INCB, and WHO. The Board agreed to discuss this further.


