

Annual General Assembly of the Vienna NGO Committee on Drugs

Due to COVID-19 the VNGOC Board decided to hold all meetings during the 65th CND online, including the Annual General Assembly. The VNGOC Board and the Nominations Committee further decided to deliver the General Assembly in two parts:

- 1. Part 1 of the AGM was held on 10th March 2022 (15:00 16:30 Vienna time) using Zoom
- 2. Part 2 of the AGM was held on <u>17th March 2021</u> (16:30-18:00 Vienna time) using Zoom

DRAFT MINUTES

AGM PART 1

1. Adoption of the Draft Agenda

The Committee **adopted** the draft agenda.

2. Attendance and apologies for absence

121 people attended Part 1 of the AGM and 84 people attended Part 2 of the AGM. 94 member organisations in good standing registered to vote in the VNGOC elections. (see Annex 1)

No apologies were received by the Secretary prior to the meeting.

3. Approval of the minutes of the last meeting

The <u>draft minutes</u> of the meeting held on 8th December 2021 have been circulated. The Committee **approved** the draft as a correct record of the meeting.

4. Board elections

The nominations committee (Amy Ronshausen, Drug Free America Foundation, Inc.; Charity Monareng, TB/HIV Care; George Ochieng Odalo, Slum Child Foundation; Ifeanyi Nwanoro, CIPDI; Jorge H Valderrábano, Instituto RIA; Marie Nougier, IDPC; Memory Usaman, Rwanda Youth Impact; Monica Barzanti, San Patrignano; Mousa Daoud, TJADS) presented the procedures for the online Board elections, which were also circulated before the meeting. The elections were held online via electionrunner.com in the following order (all times CET):

- Deputy Chairperson: Monday, 14th March 11am to Tuesday, 15th March 10am
- Treasurer: Tuesday, 15th March 11am to Wednesday, 16th March 10am
- Secretary: Wednesday, 16th March 11am to Thursday 17th March 10am



The meeting was then formally paused by Jamie Bridge (Chair) for the duration of the elections, to be resumed on Thursday 17th March, 4.30pm CET.

6. Nominations Committee

The board and the nominations committee invited the Committee to provide feedback on the election modalities.

- A slot for Youth (25 years and below) should be taken into account in the recommendations of the nominations committee

7. Membership

The Committee was informed about the latest applications for membership and the new members were officially introduced.

26 new organisations from 18 different countries were admitted since April 2021, bringing the total membership to 338 organisations. The list of new member organisations can be found here.

8. Annual Report

The Board presented the VNGOC <u>annual report</u> and reflected on activities for 2021. In particular, the Board presented civil society speaking opportunities in 2021 and the range of speakers selected by the VNGOC. The annual report was **approved**.

9. Financial Report 2021 and Budget 2022

The Board informed the Committee about the annual accounts for 2021 and the latest financial status – contained within the annual report. The Auditors, Mousa Daoud (Jordan Green Crescent) and John Redman (CADFY), confirmed their **approval** of the financial documentation.

The Board presented the budget for 2022, and the Committee approved.

10. Appointment of an auditor

The membership was asked to nominate and confirm an auditor. Mousa Daoud (The Jordan Anti Drug Society) volunteered and was **appointed for two years** (2022-2024). The term of the second auditor, John Redman (CADFY) continues until 2023 (20021-2023).

11. Strategic Plan 2022-25

The Board presented the Strategic Plan 2022-25, and the Committee approved.

12. UNODC update

The Committee received an update on developments within UNODC from the Civil Society Unit. The Civil Society Unit especially highlighted the successful webinars

13. Appointment of an auditor

The membership was asked to nominate and confirm an auditor. Beatrix Vas (Students for Sensible Drug Policy) volunteered and was **appointed for two years**, replacing Mousa Daoud (Jordan Green Crescent).



14. Any other business

The chair informed the Committee about the upcoming 40th anniversary of the VNGOC and shared some initial ideas including a possible joint reception co-hosted by the City of Vienna and UNODC.

The chair raised an issue regarding ECOSOC accreditation and the process of gaining consultative status and informed the Committee about a joint statement of the VNGOC together with NYNGOC, the Alliance of NGOs on Crime Prevention and Criminal Justice and the UNCAC Coalition.

Increasingly NGOs applying for ECOSOC consultative status are deferred by the UN Committee of NGOs for several years.
